The Council's budget includes the following line items:

The Virginia Egg Council increased the two staff employees a 3 % raise in salary effect July of 2018. Additional line items as in the Egg Board report would be to illuminate the Southern United Egg Producers and add Agriculture in the classroom program \$2,500, \$10,000 for the Virginia Poultry Federation, \$1,000 for the Agribusiness Council, \$2,000 for Office supplies, \$250 for the Family and Consumer Science Educational FCLA Project, \$10,000 for a joint venture with VDACS recipe placement in 75 kiosks in the commonwealth of Virginia.

The Board requested that a list of excise paying handlers be obtained from the Department of Taxation for review by the Virginia Egg board.

Revenue trends were reviewed and there was a slight decrease from the last year. Future program plans, and goals were discussed, and a motion was made and approved the suggested direction of the programming.

Reports were presented from Virginia Tech- Dr. Paul Ruszler, Elizabeth Myers -VDACS, Hobey Bauhan-Virginia Poultry Federation & Agribusiness Council, Rose Jeter - Ag in the Classroom, and Leonie Jacobs of VA Tech.

Egg Industry concerns were discussed. The per capita consumption of eggs has increased in the past year. The news for the egg industry throughout the country is more positive that in previous years.

The next meeting will be held in September of 2019, tentatively at the Hotel Roanoke. There was no public comment and the meeting adjourned at 1:30 pm.
