A quorum was present, Supt. Chris Walz; Asst. Supt. Felicia Cowan; Pam Westbrook; Deborah Hand; Capt. Barnes; Capt. Bhagirath; Capt. Villanueva; Jeff Rosen, Esq.; April Brumley; Rebecca Hopkins.

Call to Order

Sharon Scott (hereafter, CS) called an emergency meeting of the HRRJA Authority Board in accordance with Section 2.2-3708.2(a)(3) and 44-146.21, Code of Virginia, due to the COVID19 outbreak and the Governors stay at home order. The meeting is being held by video conferencing which is open to the public as outlined in the Meeting Notice.

Opening

CS opens the meeting welcoming everyone.

Covid-19 Virus Emergency Plan & Continuity of Operations for HRRJ

Col. Walz – I'd like to first start off by saying thank you to all the Jurisdictions for your support during this time. We currently have 43 Active cases. 10 have been clean and are back into general Population. 4 out of the 10 staff members have come back to work. Based on our medical staff's recommendations we are testing twice before placing individuals back into general population. We have also implemented a modified lockdown that will start Friday or Saturday. 2 masks have been given to each employee.

Approval of Minutes

- CS allowed time for the Members to review the minutes.
- CS asked for a motion for the Board to approve the minutes from April 15th. Linda Curtis moved to approve the minutes. Gabe Morgan seconded. A voice vote was taken with a unanimous vote. The Motion Carried.

Treasurer's Report

 Deanna Isom – Medical is still waiting on True ups. The true-ups may be less than noted, but we have not seen them yet.

Brian DeProfio – If the True ups come in lower would that decrease the cost? Deanna Isom – Yes.

• Alan Archer moved to accept the treasurer's report. Gabe Morgan Seconds. A voice vote was taken with a unanimous vote. The motion carried.

Review of operations and Activities

Medical

Pam Westbrook – Since the last board meeting we have 39 patients (hereafter Pt) receiving medications for HIV. For the Temporary Detention Orders currently it is 4 for the month of April. We have 5 pregnant females in the facility. 2 are currently on Opiate Replacement Maintenance. We have 22 Pts with Cancer. Within the facility we have 10 Pts over 65 and 4 are 70 and older. In reference to the special needs list we have 7 Pts with paraplegia. 14 that are intellectually delayed and 5 receiving dialysis. We have 1 total care Pt. We are issuing out masks for anyone going out for outside appointments. Due to Covid -19 surgeries are scheduled on a case by case basis. The Doctor will call the hospital and they will discuss to see if it is an urgent or emergent need. We have completed 124 COVID tests. Out of those tests 53 were positive and 71 were negative. We have also completed 41 re-tests in which 21 came back positive and 19 came back negative. Our PPE is listed on the insert as well. For our staffing matters, we have had some issues with COVID going on. We have had 2 staff members test positive. We have had 10 staff members who are out or who have been out for 14 days based on their doctor's recommendation or they were showing signs and symptoms. We have had some Nurses who have quit with COVID going on because they have higher morbidity. We are working very hard to get Nurses on and we have 2 starting this week.

Sharon Scott – Are you using a Temp Agency to try to fill these positions? Pam Westbrook – Yes, we are.

Gabe Morgan – How are you screening the Temp Nurses? I know most of the time these nurses are working multiple places.

Pam Westbrook – Well they are screened by Wellpath and the Jail has their own screening as well. We are also requesting that these nurses do not work at any other sites. If they are Wellpath employees they are not allowed to work at any other sites.

Karen Bowden - How many nurses are you down?

Pam Westbrook – We are down about 9 RNs, 2 LPNs, and about 3 CMTs Karen Bowden – What type of training are they receiving?

Pam Westbrook – They are still receiving the training that is about 3-6 weeks. As of right now we only have 2 nurses that are from a temp agency.

- Gabe Morgan I do have some concerns with the level of staffing. I think we need to address this with Wellpath above the area management.
- Sharon Scott We will get together to address this at a later time.

Security

 Capt, Bhagirath – We currently have 8 going to the Academy. Officers are coming to work and completing their shifts. We are not doing quarterly searches for safety reasons and reduce the number of officers around inmates. Our Medical staff has supported our security staff and I just want to thank them.

Human Resources

• April Brumley – We currently have 19 vacancies. For the month of April, we had 5 immediate resignations and 1 retirement. We had several recruitment events lined up but because of Covid-19 those have been canceled. As a result we have moved to aggressive recruitment online via, indeed, Facebook, Linkdin, as well as our Website. We have switched from face to face interviews to phone interviews and video interviews when possible. We are actively interviewing and testing applicants on a weekly basis for the position of Jail Officer. We are not doing our training class for the Month of May because our training department is out due to a possible exposure to a COVID positive employee.

Sharon Scott - You said your training department is out.

April Brumley – Yes, we are not having a training class in May but we have one scheduled for June and July.

Sharon Scott – We need to get a handle on this so we don't get short staffed. April – I think we will not have an issue filling our June and July classes.

Maintenance Projects

• Capt. Barnes — For our jurisdictional runs for the city of Chesapeake — 11 runs, Hampton a total of 22, Newport News a total of 29, Norfolk 24 and Portsmouth had 9. Transportation runs to include courts, bonding and releases to total 95. We had 0 trips to DOC, 21 to Maryview Hospital, 28 to Norfolk General, 6 runs via ambulance, 16 ER runs by jail transport, 49 scheduled medical appointments, and 16 runs to the mental health facilities. If you include everything it is 231 and then the return trips to the facility are 269, for a grand total of 500 transportation runs.

 Capt. Barnes – We also have some projects that have been placed on hold since COVID-19. I did report that we had some issues with our doors in one of our housing units. Those have been fixed.

Mental Health Grant

 Bruce Hurdle – The CSB staff has been working off site with the COVID pandemic that is going on. We have been doing video visits with our clients to check in with them. We screen 42 inmates and 35 of those were enrolled with the grant.

Gabe Morgan – How are we financially with that grant?

Debbie Hand – We are coming in under budget because of some vacancy savings in the beginning of the year. We expect to come in well under budget. We were paying for seeking safety and thinking for a change and those have

stopped because of COVID so we will be under budget.

Gabe Morgan – Have we figured out if we can use any of that money someplace else?

Debbie Hand – We have requested that but the grant does limit us.

CS – Does anyone have anything else they would like to say before we adjourn?

CS – That is all of our agenda items. I would entertain a motion to adjourn. Linda Curtis Motioned for adjournment and Martin Thomas seconded. A voice vote was taken with a unanimous vote. CS adjourned the meeting.

The next meeting is scheduled for June 17, 2020.




