**CALL TO ORDER**

**EXECUTIVE SESSION**

**The motion was made and passed to go into Executive Session pursuant to Virginia Code, 2.2-3711-A (15), for the purpose of conducting a Next Friend review. Members present were Michael Williams and Anna Jennings.**

1. Present was Horizon Behavioral representative Megan Martin as well as Sharon Whitten and the individual. **The motion was made and unanimously carried to appoint Eric Baber as Next Friend for this individual.**
2. Present was Horizon Behavioral Health representative Shayna Bannon, as well as Rebecca Drinkard with Lutheran Family Services. Sheryl Hunt and the individual were also present. This Next friend was heard at the previous LHRC from another provider. No motion was required at this meeting. **The motion was made and unanimously carried to appoint Sheryl Hunt as Next Friend for this individual on January 24, 2017.**

**The motion was made and passed to go into Executive Session pursuant to Virginia Code, 2.2-3711 (15), for the purpose of discussing the restrictive treatment plans for individuals receiving service. This review necessarily involved discussion and consideration of mental and medical records excluded and information excluded from the Freedom of Information Act. Members present were Michael Williams and Anna Jennings.**

1. Present was DePaul Community Resources representative Ryan Long. Four plans were heard. **The motion was made and unanimously carried to approve three plans, to be reviewed in one year, and to acknowledge the review of the other plan however it did not require review due court ordering this plan be put in place.**
2. Present were Able Home's representative Francine Baruti. 2 plans were heard and determined to be Mechanical Restrictions that only required notification to the LHRC.

**The motion was made and unanimously carried to nominate Ann Jennings as a member, for final approval at the next meeting of the State Human Rights Committee.**
