Welcome and Introductions

The meeting was called to order at 10:12. Meeting attendees introduced themselves, including their position and the organization they represent.

Approval of May 2025 Meeting Minutes

Minutes from the August 2025 VOSAP meeting were approved.

Speaker: Tiffany Eustice of Virginia Department of Health gave a presentation on youth and young adult tobacco cessation efforts. Slides are attached alongside these minutes.

VOSAP Updates

Wyatt is reaching out to everyone individually with their respective sections of the Annual Report and any questions. It will receive additional revisions in September.

One general theme of the report is that compared to national data from the Youth Risk Behavioral Surveillance System, the Virginia Youth Survey shows lower rates of youth substance use. This is for 2023 data, as 2025 data has not been published yet.

There are some trends that while not overt in survey data, may be showing up in Virginia when 2025 data is available. E-cigarette use is down nationally, as youth nicotine pouch use has increased. This corresponds to reports of increased calls to Virginia's poison control centers.

Some ideas were shared for this fiscal year. These included developing a shared calendar of recurring events, campaigns and conferences. Additionally, it was proposed that resources be developed or shared to assist in calculating prevention programs' return on investment.

Group Discussion

Michael Parsons confirmed that the 2025 Virginia Youth Survey has a question relating directly to nicotine pouch use, making it useful for tracking this emerging trend.

Colleen Hughes shared that she is working on some resources for communicating prevention's return on investment and can share more as they are developed.

ABC News and Updates

<u>Youth Alcohol and Drug Abuse Prevention Project</u> (YADAPP) was a success. High school students from across the state came together at Christopher Newport University to develop their leadership skills and build plans to prevent drug and alcohol use in their skills and communities.

As a part of the Miss Virginia School Tour program, Miss Virginia visits elementary schools around the state with a message of healthy decisions and substance use prevention. As a part of the Power of Parents program, we distribute handbooks for parents on best practices for having conversations with their teens about alcohol and other drugs. Together with MADD Virginia, we also offer training presentations to groups on the themes of the handbook with Virginia specific data and practical tips, online or in-person.

We have posted <u>Virginia Alcohol Health & Safety</u> Community Dashboards on our website, displaying alcohol health and safety data and trends across the state.

Additionally, we are establishing a state-wide group to serve as a public resource for alcohol research, data and health behaviors called the Virginia Alcohol Research Consortium. To join, email Matt Santucci (matthew.santucci@virginiaABC.com).

CCA News and Updates

Sakina Weekes has joined the Virginia Cannabis Control Authority as an education and prevention specialist. The CCA also hired other positions, including an outreach coordinator and a compliance and enforcement specialist. There is also a new board member.

A practitioner training is currently being developed for cannabis, and the next Safe Driving Campaign is expected to launch in October. There are currently lots of educational resources available at https://cca.virginia.gov/.

DBHDS News and Updates

Navigating a new structure with new strategic plan covering July 1, 2025 – June 30, 2030. Aiming to address risk/protective factors in a strategic way to best support CSBs. Synar inspections are currently underway. This year, Community Coalitions of Virginia will not be hosting their annual conference but will offer a webinar training series to try and fill the gap.

Mental health conference on trauma-informed care geared towards refugees and immigrants September 15.

DCJS News and Updates

Strengthening Connections Conference will be held February 10-11 at The Crossings. Usually about 300 attendees, and there are lots of opportunities for state agencies to table.

Various trainings and events are coming up that may be of interest. These include a training on building healthy relationships for youth, October 9 in Fredericksburg, and the First Responder Wellness Conference, September 9-11 in Norfolk.

VDH News and Updates

Agency updates were shared within presentation slides. Additionally, shared that Stanford's REACH Lab has fantastic free prevention toolkits and resources.

Elle and Jada from the Crater Health District shared that funding was granted to Petersburg and Hopewell for opioid prevention work. They are collaborating with GMU and VSU on a four-to-six-part education series to be used in two prisons in the district. This will include REVIVE training and overdose awareness. The E-bridges program exists, where if an individual overdoses, they are supported with resources and peer recovery efforts.

VDOE News and Updates

Developed guidelines for parental notification when there is an overdose or suspected overdose in accordance with legislation.

Awarded new funding to train 200 new educators each year on delivering Botvin LifeSkills Training curriculum. Providing Health and Physical Education with video guides and support to help teach the SOLs related to opioid abatement. Will be working on modules for teens (9th-12th grade) on the neuroscience of addiction (and how opioids affect it specifically). Also received funding for recovery schools' technical assistance grants.

A convention is coming up in early November for university professors who teach education students. Currently gathering prevention resources in a one-stop shop for educators.

VDSS News and Updates

VDSS has been promoting, <u>211 Virginia</u>, central source for referrals and human service resources. supported by a grant from the Opioid Abatement Authority, the Opioid Reduction Registry is its latest initiative, designed to expand access to opioid-related support services across the Commonwealth. A virtual informational session is taking place August 27 to provide an overview of the registry, its integration into 211 and ways to support these efforts.

This work is. Additionally, <u>Kinship Navigator</u> assists kinship caregivers by providing resources for financial assistance, legal guidance, and other types of issues caregivers face when raising children in order to provide stability and support in the home.

VSP News and Updates

Youth of Virginia Speak Out About Traffic Safety (YOVASO)'s 2025 Summer Leadership Retreat at JMU was successful. It had 125 students, and evaluation survey results indicated they felt motivated to help their communities after participating in the retreat. The retreat is expected to be the same week and same location in 2026.

A new youth advisory council was selected. These students represent communities across the state. There are also two new distracted driving simulators that schools can request.

Drive for Change campaign is coming up registration opens August 25. The campaign runs September 15 - October 14. Focus is on buckling up and slowing down. Those who sign up receive a box with items and resources in order to implement the project in school. Schools have the choice to compete within the project to win \$500.

Agency wide, two initiatives are going on right now. The Drive Sober or Get Pulled Over campaign, along with high-volume trooper presence on the roads as we approach Labor Day weekend. Early traffic fatalities data indicate a substantial decrease in 2025.

VFHY

Adapted the hour-long high school fentanyl awareness lesson for middle school. Expected to award 35 groups with grant funding to implement a prevention education starting in October. Created to be easy for schools to apply and implement. The third Champions for Youth Summit will be May 3-5 in Northern Virginia. Topics to include fentanyl, health and wellness, and more.

MADD

MADD Virginia partners with Virginia ABC on the Power of Parents program and is happy to support groups with handbooks and training presentations. MADD also offers Power of Youth program, a complementary program directed at teens.

Partners with national office on Saturation Saturday campaign ahead of Laboy Day weekend. Additionally, MADD offers law enforcement awards, where officers making an impact at preventing drunk driving are recognized at an event in December. Last year's event had over 300 attendees.

Radford University



Leveraging Taxes for Prevention

2021 Update: Counties can increase cigarette taxes up to 40¢/pack (effective July 2021)

• State Tax: 60¢/pack


• City Taxes: Some cities already implement local taxes

HB 947: Locality can regulate any retail sale location



- Any locality can prohibit any new tobacco retailers from opening within 1000 feet of child day center, public private or parochial school.
- Including nicotine vapor products, alternative nicotine products, or hemp products intended for smoking.

Schools



Addressing Student Tobacco Use in Schools: Alternative Measures

Using suspension and expulsion to penalize prohibited commercial tobacco use may not be reasonable considering the targeted marketing, science of addiction, and long-term consequences associated with expulsion and suspension.

School policies should attempt to address the underlying addiction to commercial tobacco in lieu of purely punitive measures, which may exacerbate the problem and not deter future use.





Assessing Vaping Exposure Risk for Teens (AVERT): A Resource Linkage Tool

Connecting professionals to risk-based assessment and resources for vaping prevention and cessation for teens.




Themes and Trends

• Most recent Virginia Youth Survey Data (2023) showed broad decreases youth substance use, corresponding with national data.

- Important to pay attention to developing trends ahead of the 2025 Virginia Youth Survey.
 - While e-cigarette use is down nationally, increases in youth nicotine pouch use.
 - Corresponds to increased calls to Virginia's poison control centers.
